Erection of timber outbuilding in rear garden, to include windows and door (Retrospective)

 - 4.2** [25/01579/ROC](#) **1 Maynards Wood Chineham Hampshire RG24 8DP**
Variation of condition 1 of 24/01625/HSE (Erection of a two storey front extension, conversion of existing roof space over garage involving raising of the roof, construction of 1 no. dormer and alterations, following demolition of existing bay window) to allow for relocation of existing entrance to front elevation with additional changes to fenestration and doors.

The Chineham Parish Council discussed the proposed addition of the first floor window as part of the planning application. It was noted that the positioning of the new window would directly overlook the adjacent neighbouring property, raising concerns about infringement on the occupants' privacy.

	<i>In addition to the concerns about the additional first floor side window, the CPC also raised issues regarding the front-facing window. Councillors felt the design to visually overbearing and out of keeping with the established street scene.</i>
